#### **Foreword**

Personal Health Choices is a joint publication of the Comagine Health and the Nevada Health Authority. This report presents general acute care hospital outpatient emergency department discharge billing records data for 15 common medical diagnoses as reported by Nevada's general acute care hospitals that discharged patients within the period.

The data are available through the standard Uniform Billing form, which is utilized by hospitals to bill for hospital charges. The data include patients who were admitted to a hospital through the emergency department and were not transferred to an inpatient admission. The data identify billed charges, not the actual payments received by the hospital.

The data were compiled by Comagine Health using information from outpatient hospital billing records. This information was gathered and analyzed as part of a contractual agreement between the Department of Health and Human Services and Comagine Health under the authority granted in Section 439B of the Nevada Revised Statutes. Comagine Health reviews the data and requests corrections when errors are found. It is not possible to detect all errors. Comagine Health is not responsible for errors that cannot be found by a review.

#### Introduction

This Book 3 of Personal Health Choices compares 38 of Nevada's general acute care hospitals with respect to 15 common categories of diagnoses that would be treated in the emergency department, defined by Clinical Classification Software Refined (CSSR) using ICD-10-CM diagnosis codes (CCSR: see below). The definitions to all CCSR used in this report can be found on the narrative page for each CCSR grouping.

## Clinical Classification Software Refined (CSSR) System

Clinical Classification Software Refined (CCSR) is a group developed by the Agency for Healthcare Research and Quality. It groups diagnosis codes into clinically meaningful categories for reporting.

For this report, Comagine Health grouped specific CCSRs into 15 common categories of diagnoses that would be provided by acute care hospital emergency departments.

#### **Additional Information**

Personal Health Choices is intended as a source of information regarding the billed charges of hospitals in Nevada and should not be construed as a definitive guide for selecting a hospital to receive medical care. The financial information in this report is based on the hospital billed charges and not the amount that was actually paid to the hospital. Billed charges and paid amounts can differ significantly. This report provides the reader information about one component of health care pricing – emergency department visits. Professional physician and other non-hospital inpatient ancillary health care services are not covered in this report.

## **Report Navigation**

This report includes outpatient emergency department visits from acute care hospitals where the visit occurred from calendar year 2022 through calendar year 2024.

Each CCSR group is introduced with a short narrative that describes the CCSRs included in the group. The narrative information is based on the available data and contains information on the primary diagnosis related to the emergency department visit.

After the narrative, a series of tables and charts are presented that include the number of discharges and the average billed per discharge for the CCSR group. The first table presents statewide averages along with gender and age breakdowns. The first table is followed by three charts to illustrate that same information. Following the charts will be three tables that contain the information by hospital for Clark County, Carson City/Washoe County and rural counties.

It should be noted that when comparing hospitals, information based on small numbers of cases cannot provide a reliable statistical base upon which information can reflect a given hospital's experience. Rows that include five or fewer discharges are suppressed in this report, but caution should still be used when interpreting the data.

Further, physician charges (including those of surgeons) are normally separate from hospital charges, except in rural areas where some physician services – such as radiology, anesthesia, and laboratory tests – may be included in the hospital charges.

Comagine Health receives patient discharge records directly from all the hospitals included in this report.

# **CCSR Groups – Discussion and Graphics**

### 1. Pneumonia and Other Specified/Unspecified Respiratory Disease

<u>CCSR:</u> Respiratory congenital malformations (MAL007), Respiratory distress syndrome (PNL005), Respiratory perinatal condition (PNL006), Pneumonia (except that caused by tuberculosis) (RSP002), Other specified and unspecified upper respiratory disease (RSP007), Respiratory failure; insufficiency; arrest (RSP012), Other specified and unspecified lower respiratory disease (RSP016), Postprocedural or postoperative respiratory system complication (RSP017)

<u>Definitions:</u> Asthma: Chronic inflammatory disease of the airways. **Bronchitis:** An inflammation of the air passages between the nose and the lungs, including the windpipe or trachea and the larger air tubes of the lung that bring air in from the trachea (bronchi). **Bronchial tubes:** The major airways to the lungs and their main branches. **Croup:** An infection of the upper airway, generally in children, which obstructs breathing and causes a characteristic barking cough. **Larynx:** The structure between the pharynx and the trachea that contains the vocal cords. **Pharynx:** The upper expanded portion of the digestive tube, between the esophagus below and the mouth and nasal cavities above and in front. **Trachea:** A tube-like portion of the respiratory tract that connects the larynx with the bronchial parts of the lungs. Also known as windpipe. **Bronchiolitis:** An acute viral infection of the small air passages of the lungs called the bronchioles. **Bronchioles:** Small airways extending from the bronchi into the lobes of the lungs. **Pneumonia:** Inflammation of the lungs, usually due to infection with bacteria, viruses, or other pathogenic organisms.




Chart ED 1-A Patient Discharges (Cases)




Chart ED 1-B Average Billed Charges (Avg Bill)

## 2. Headache Including Migraine

**CCSR:** Headache; including migraine (NVS010)

<u>Definitions:</u> Migraine: A severe recurring headache, usually affecting only one side of the head, that is characterized by sharp pain and is often accompanied by nausea, vomiting, and visual disturbances. Hypertension: High blood pressure. Diabetes mellitus: A condition in which the pancreas no longer produces enough insulin or cells stop responding to the insulin that is produced, so that glucose in the blood cannot be absorbed into the cells of the body.




Chart ED 2-A Patient Discharges (Cases)




Chart ED 2-B Average Billed Charges (Avg Bill)

## 3. Upper Respiratory Infections Including Allergic Reactions and Otitis Media

Tonsillitis: Inflammation of the tonsils. Croup: An infection of the upper airway, generally in children, which obstructs breathing and causes a characteristic barking cough. Sinusitis: Inflammation of a nasal sinus. Streptococcus: A genus of nonmotile, non-spore-forming, aerobic to facultatively anaerobic bacteria containing grampositive, spherical, or ovoid cells that occur in pairs or short or long chains. These organisms occur regularly in the mouth and intestines of humans and other animals, in dairy products and other foods, and in fermenting plant juices. Some species are pathogenic. Suppurative otitis media: Otitis media with the presence of purulent fluid in the middle ear. Purulent: Containing, discharging, or causing the production of pus.




Chart ED 3-A Patient Discharges (Cases)




Chart ED 3-B Average Billed Charges (Avg Bill)




Chart ED 4-A Patient Discharges (Cases)




Chart ED 4-B Average Billed Charges (Avg Bill)






Chart ED 5-B Average Billed Charges (Avg Bill)

Costal cartilages: The cartilages that connect the sternum and the ends of the ribs; its elasticity allows the chest to move in respiration. **Esophageal reflux**: Regurgitation of the contents of the stomach into the esophagus. **Hyperlipidemia**: An abnormally high concentration of fats or lipids in the blood. **Precordial pain**: Pain in the chest wall over the heart.




Chart ED 6-A Patient Discharges (Cases)




Chart ED 6-B Average Billed Charges (Avg Bill)






Chart ED 7-B Average Billed Charges (Avg Bill)




Chart ED 8-A Patient Discharges (Cases)




Chart ED 8-B Average Billed Charges (Avg Bill)




Chart ED 9-A Patient Discharges (Cases)




Chart ED 9-B Average Billed Charges (Avg Bill)



Antibiotics can treat most UTIs. **Calculus of Urinary Tract:** Stones (calculi) are hard masses that form in the urinary tract and may cause pain, bleeding, or an infection or block of the flow of urine.




Chart ED 10-B Average Billed Charges (Avg Bill)




Chart ED 11-A Patient Discharges (Cases)




Chart ED 11-B Average Billed Charges (Avg Bill)

<u>Definitions</u>: Urticaria: An eruption of itching wheals, colloquially called hives, usually of systemic origin; it may be due to a state of hypersensitivity to foods or drugs, foci of infection, physical agents (heat, cold, light, friction), or psychic stimuli. **Scabies**: A contagious disease caused by Sarcoptes scabiei, the human itch mite, characterized by intense itching of the skin and excoriation from scratching. **Dermatitis**: A general term used to describe inflammation of the skin. **Dermatophytosis**: An infection of the hair, skin, or nails caused by any one of the dermatophytes (fungus parasitic upon the skin). **Candidiasis**: An infection caused by a species of the yeast Candida, usually Candida albicans. **Sebaceous cyst**: A rounded swollen area of the skin formed by an abnormal sac of retained excretion (sebum) from the sebaceous follicles. **Mastodynia**: Pain in the breast.




Chart ED 12-A Patient Discharges (Cases)




Chart ED 12-B Average Billed Charges (Avg Bill)

<u>Definitions:</u> Exanthem: A skin eruption or rash. Pharyngitis: Inflammation of the pharynx, causing a sore throat. Varicella: (AKA chickenpox) An acute contagious disease, usually occurring in children, caused by the varicella-zoster virus and marked by a sparse eruption of papules, which become vesicles and then pustules, usually with mild constitutional symptoms; incubation period is about 14-17 days. Coxsackie virus: Any of a group of enteroviruses that cause various respiratory, neurological, and muscular diseases in humans. Enterovirus: A genus of picornaviruses, including polioviruses, coxsackieviruses, and echoviruses, that infect the gastrointestinal tract and often spread to other areas of the body, especially the nervous system.




Chart ED 13-A Patient Discharges (Cases)




Chart ED 13-B Average Billed Charges (Avg Bill)

In a healthy pregnancy, the placenta is an organ that grows in the uterus and nourishes a developing baby through the umbilical cord. **Polyhydramnios:** The buildup of increased amniotic fluid — the fluid that surrounds the baby in the uterus during pregnancy. **Hypertension:** High blood pressure.




Chart ED 14-A Patient Discharges (Cases)




Chart ED 14-B Average Billed Charges (Avg Bill)




Chart ED 15-A Patient Discharges (Cases)




Chart ED 15-B Average Billed Charges (Avg Bill)
