## Foreword

Personal Health Choices is a joint publication of the Comagine Health and the Nevada Health Authority. This report presents specialty care hospital inpatient discharge billing records data for 11 common Medicare Severity Diagnosis-Related Groups (MS-DRG) as reported by Nevada’s specialty care hospitals that discharged patients within the period.

The data are available through the standard Uniform Billing form, which is utilized by hospitals to bill for their hospital charges. The data include patients who were admitted to a hospital as an inpatient but does not include patients who were treated and released from the outpatient setting. The data identify billed charges, not the actual payments received by the hospital.

The data were compiled by Comagine Health using information from inpatient hospital billing records. This information was gathered and analyzed as part of a contractual agreement between the Department of Health and Human Services and Comagine Health under the authority granted in Section 439B of the Nevada Revised Statutes. Comagine Health reviews the data and requests corrections when errors are found. It is not possible to detect all errors. Comagine Health is not responsible for errors that cannot be found by a review.

## Introduction

Book 2 of Personal Health Choices compares 22 of Nevada's specialty care hospitals with respect to 11 common categories of diagnoses that would be provided by specialty hospitals, defined by Medicare Severity Diagnosis Related Groups (MS-DRGs: see below). The definitions to all DRGs can be found on the narrative page for each DRG grouping.

## Centers for Medicaid and Medicare Services (CMS) Medicare Severity Diagnosis Related Group (MS-DRG) System

The CMS Medicare Severity Diagnosis Related Group (MS-DRG) is a classification system that is based on principal and secondary disease diagnoses, medical and surgical procedures, complications, comorbidities (coexisting conditions), age and discharge status. The DRG system is complex in its construction and is based on documentation in the patient's medical record. DRGs are divided into 25 exclusive categories referred to as major diagnostic categories (MDCs). DRGs enable hospitals to recover the appropriate reimbursement for services rendered, evaluate the quality of care and assist in evaluating utilization of services. The DRGs classify patients with similar utilization of hospital resources and length of stay patterns. Each DRG represents the average resources needed to treat patients grouped to that DRG compared to the national average of resources to treat all Medicare patients. Hospitals are reimbursed at a flat rate based on the theory that patients with similar illnesses undergoing similar procedures will require similar care. The primary outcome of the DRG system is the more efficiently a hospital delivers care, the greater its operating margin will be.

For this report, Comagine Health grouped specific DRGs into 11 common categories of services that would be provided by specialty hospitals.

## Additional Information

Personal Health Choices is intended as a source of information regarding the billed charges of hospitals in Nevada and should not be construed as a definitive guide for selecting a hospital to receive medical care. The financial information in this report is based on the hospital billed charges and not the amount that was actually paid to the hospital. Billed charges and paid amounts can differ significantly. This report provides the reader information about one component of health care pricing — inpatient hospitalization. Hospital outpatient services as well as professional physician and other non-hospital inpatient ancillary health care services are not covered in this report.

## Report Navigation

This report includes inpatient discharges from specialty hospitals where the discharge occurred from calendar year 2022 through calendar year 2024.

Each MS-DRG group is introduced with a short narrative that describes the MS-DRGs included in the group. Note that DRGs are sometimes broken down by age factors and/or presence of comorbidity. Comorbidity or comorbid conditions are defined as two or more coexisting medical conditions. The narrative information is based on the available data and may contain information on specific diagnoses and surgical procedures involved in the treatment of the patient. These diagnoses and procedures may not always be directly related to the primary ailment.

After the narrative, a series of tables and charts are presented that include the number of discharges, the average length of stay, the average billed per discharge and the average billed per day for the MS-DRG group. The first table presents statewide averages along with gender and age breakdowns. The first table is followed by three charts to illustrate that same information. Following the charts will be two tables that contain the information by hospital for both Clark county and Carson City/Washoe county.

It should be noted that when comparing hospitals, information based on small numbers of cases cannot provide a reliable statistical base upon which information can reflect a given hospital's experience. Rows that include five or fewer discharges are suppressed in this report, but caution should still be used when interpreting the data.

Further, physician charges (including those of surgeons) are normally separate from hospital charges, except in rural areas where some physician services — such as radiology, anesthesia, and laboratory tests — may be included in the hospital charges.

Comagine Health receives patient discharge records directly from all the hospitals included in this report.

# 1. Respiratory Diagnosis with Ventilator (207-208) (MDC 04)

**MS-DRG(s):** **207** - Respiratory System Diagnosis With Ventilator Support >96 Hours; **208** - Respiratory System Diagnosis With Ventilator Support ≤96 Hours;

**Definitions:** **Gastrostomy:** A surgical opening into the stomach. **Tracheostomy:** An operation to make an opening into the trachea. **Pneumonia:** Inflammation of the lungs, usually due to infection with bacteria, viruses, or other pathogenic organisms. **Encephalopathy:** Disease, damage, or malfunction of the brain. **Anemia:** A condition marked by a deficiency of red blood cells or of hemoglobin in the blood, resulting in pallor and weariness; diminishes the capacity of the blood to carry oxygen. **Acute kidney failure:** Occurs when illness, infection, or injury damages the kidneys. Temporarily, the kidneys cannot adequately remove fluids and wastes from the body or maintain the proper level of certain kidney-regulated chemicals in the bloodstream. **Urinary tract infection:** Microbial infection, usually bacterial, of any part of the urinary tract; may involve the parenchyma of the kidney, the renal pelvis, the ureter, the bladder, the urethra, or combinations of these organs.

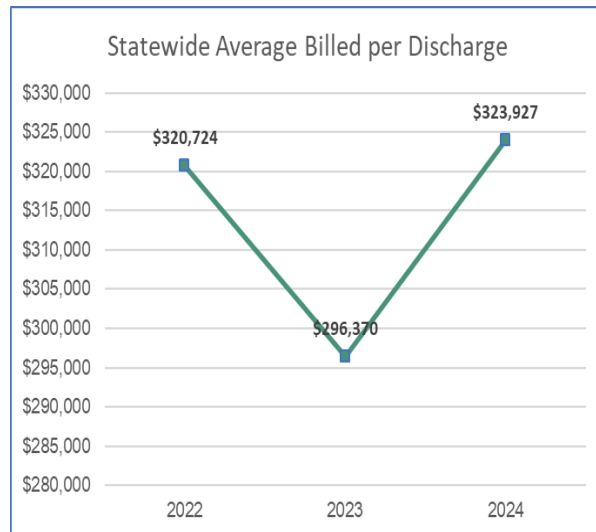


Chart IP 1-A Patient Discharges (Cases)

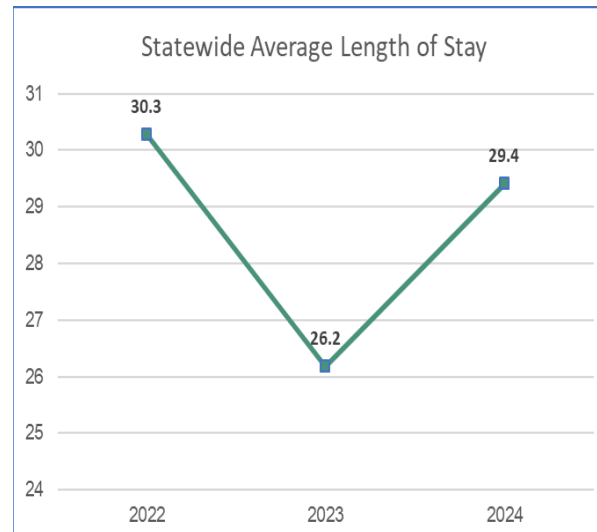


Chart IP 1-B Average Length of Stay (Avg LOS)

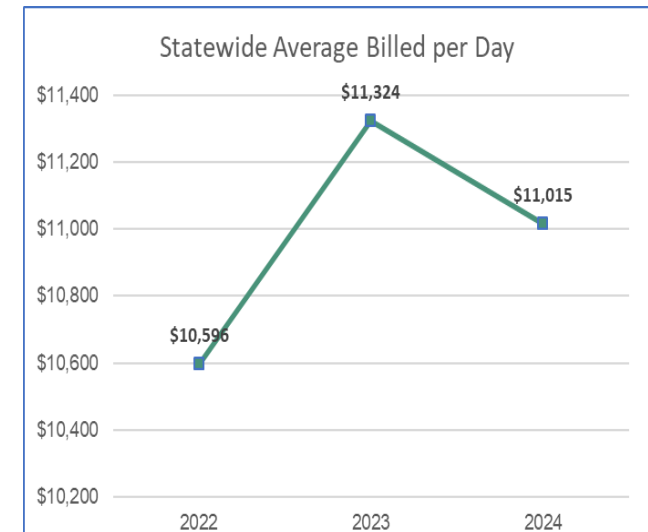


Chart IP 1-C Average Billed Charges (Avg Bill)

## 2. Osteomyelitis (539-541) (MDC 08)

**MS-DRG(s):** **539** - Osteomyelitis With MCC; **540** - Osteomyelitis With CC; **541** - Osteomyelitis Without CC/MCC.

**Definitions:** **Pressure ulcer:** An area of skin that breaks down when something keeps rubbing or pressing against the skin. **Pressure ulcer, stage IV:** The pressure ulcer has become so deep that there is damage to the muscle and bone, and sometimes to tendons and joints. **Anemia:** A condition marked by a deficiency of red blood cells or of hemoglobin in the blood, resulting in pallor and weariness; diminishes the capacity of the blood to carry oxygen. **Hypertension:** High blood pressure. **Urinary tract infection:** Microbial infection, usually bacterial, of any part of the urinary tract; may involve the parenchyma of the kidney, the renal pelvis, the ureter, the bladder, the urethra, or combinations of these organs. **Osteomyelitis:** An infection of the bone or bone marrow. **Atrial fibrillation:** An irregular and often very fast heart rate. The heart's two upper chambers (the atria) beat chaotically and irregularly - out of coordination with the two lower chambers (the ventricles) of the heart.

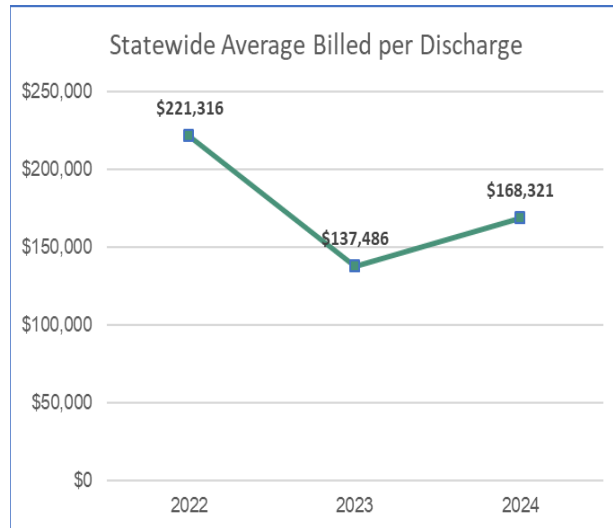


Chart IP 2-A Patient Discharges (Cases)

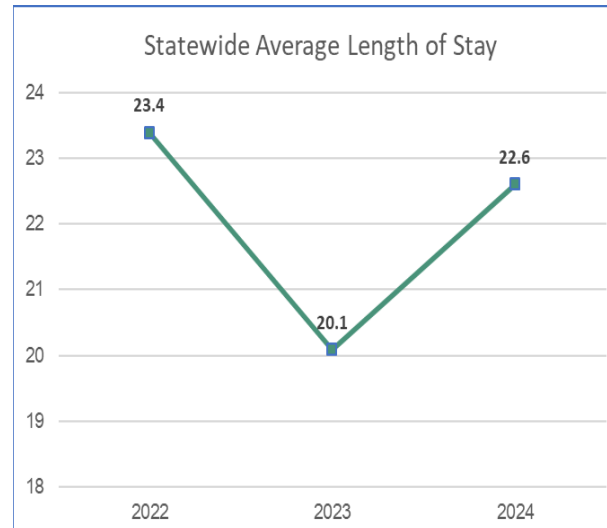


Chart IP 2-B Average Length of Stay (Avg LOS)

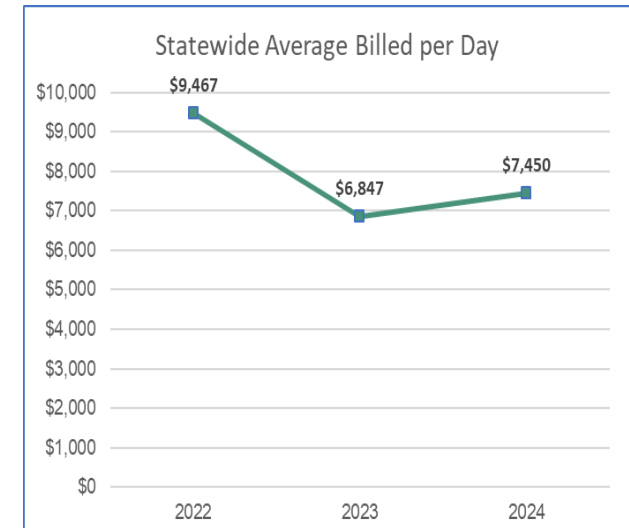


Chart IP 2-C Average Billed Charges (Avg Bill)

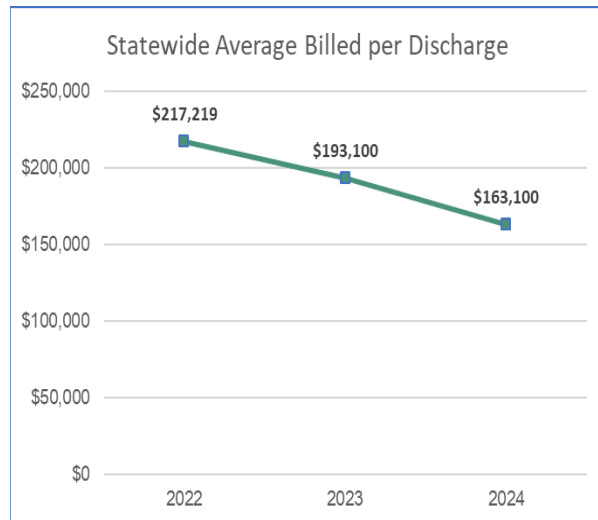


Chart IP 3-A Patient Discharges (Cases)

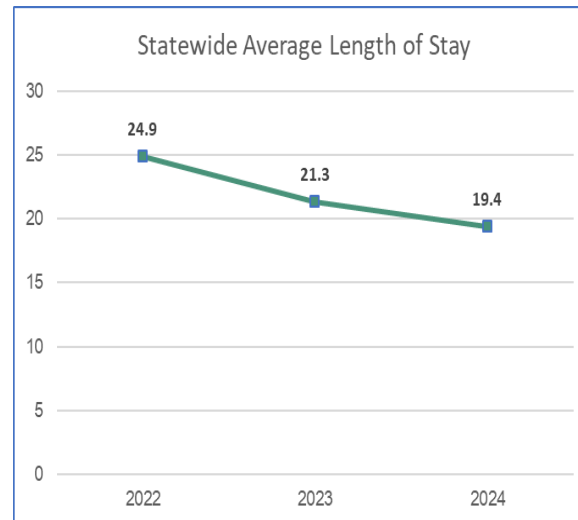


Chart IP 3-B Average Length of Stay (Avg LOS)

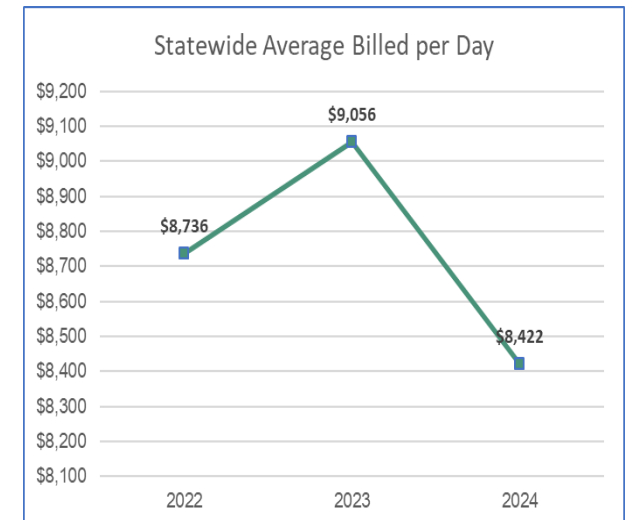


Chart IP 3-C Average Billed Charges (Avg Bill)

**MS-DRG(s):** **682** - Renal Failure With MCC; **683** - Renal Failure With CC; **684** - Renal Failure Without CC/MCC.

**Definitions:** **Debility:** The state of being weak or feeble; infirmity. **Chronic kidney disease stage V or end stage renal disease:** A progressive loss in renal function over a period of months or years. Stage 5 being the final stage of kidney failure that is marked by the complete or nearly complete irreversible loss of renal function. **Pneumonia:** Inflammation of the lungs, usually due to infection with bacteria, viruses, or other pathogenic organisms. **Urinary tract infection:** Microbial infection, usually bacterial, of any part of the urinary tract; may involve the parenchyma of the kidney, the renal pelvis, the ureter, the bladder, the urethra, or combinations of these organs. **Acute kidney failure:** Occurs when illness, infection, or injury damages the kidneys. Temporarily, the kidneys cannot adequately remove fluids and wastes from the body or maintain the proper level of certain kidney-regulated chemicals in the bloodstream. **Lesion:** Any abnormal change involving any tissue or organ due to disease or injury. **Tubular necrosis:** The death of cells in the small tubules of the kidneys as a result of disease or injury. **Congestive heart failure:** Inability of the heart to keep up with the demands on it, with failure of the heart to pump blood with normal efficiency. **Anemia:** A condition marked by a deficiency of red blood cells or of hemoglobin in the blood, resulting in pallor and weariness; diminishes the capacity of the blood to carry oxygen.

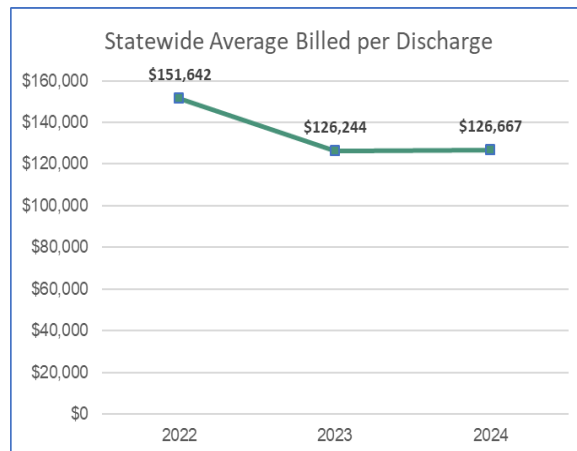


Chart IP 4-A Patient Discharges (Cases)

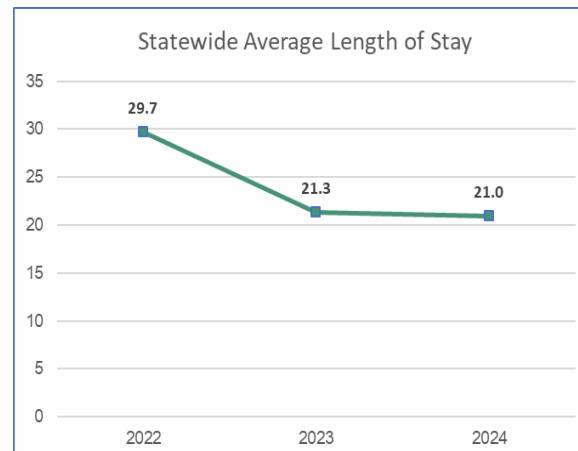


Chart IP 4-B Average Length of Stay (Avg LOS)

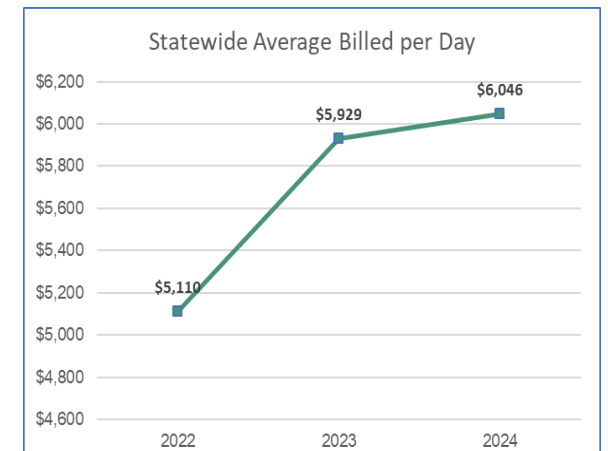


Chart IP 4-C Average Billed Charges (Avg Bill)

## 5. Septicemia Or Severe Sepsis (870-872) (MDC 18)

**MS-DRG(s): 870** - Septicemia Or Severe Sepsis With MV >96 Hours; **871** - Septicemia Or Severe Sepsis Without MV >96 Hours With MCC; **872** - Septicemia Or Severe Sepsis Without MV >96 Hours Without MCC;

**Definitions: Sepsis:** The presence of bacteria (bacteremia), other infectious organisms, or toxins created by infectious organisms in the bloodstream with spread throughout the body. **Septicemia:** Systemic disease caused by the spread of microorganisms and their toxins through circulating blood; formerly called "blood poisoning". **Pneumonia:** Inflammation of the lungs, usually due to infection with bacteria, viruses, or other pathogenic organisms. **Urinary tract infection:** Microbial infection, usually bacterial, of any part of the urinary tract; may involve the parenchyma of the kidney, the renal pelvis, the ureter, the bladder, the urethra or combinations of these organs. **Acute kidney failure:** Occurs when illness, infection, or injury damages the kidneys. Temporarily, the kidneys cannot adequately remove fluids and wastes from the body or maintain the proper level of certain kidney-regulated chemicals in the bloodstream. **Acute respiratory failure:** A sudden inability of the lungs to maintain normal respiratory function. The condition may be caused by an obstruction in the airways or by failure of the lungs to exchange gases in the alveoli. **Chronic kidney disease stage V or end stage renal disease:** A progressive loss in renal function over a period of months or years. Stage 5 being the final stage of kidney failure that is marked by the complete or nearly complete irreversible loss of renal function. **Atrial fibrillation:** An irregular and often very fast heart rate. The heart's two upper chambers (the atria) beat chaotically and irregularly - out of coordination with the two lower chambers (the ventricles) of the heart.

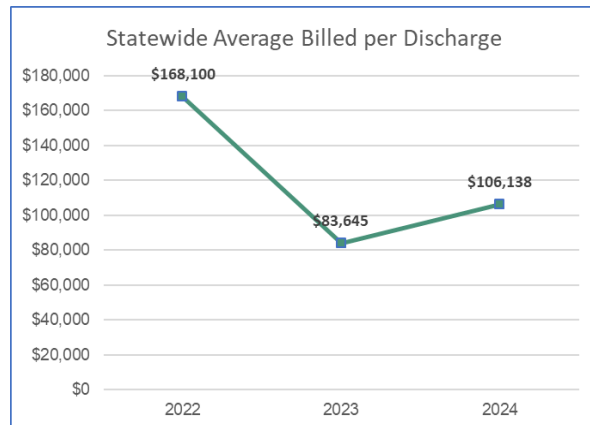


Chart IP 5-A Patient Discharges (Cases)

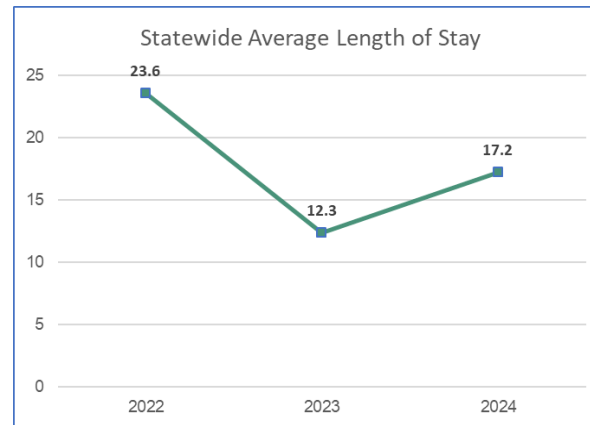


Chart IP 5-B Average Length of Stay (Avg LOS)

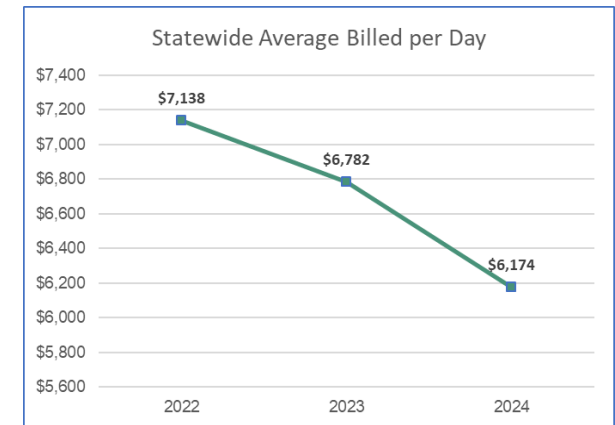


Chart IP 5-C Average Billed Charges (Avg Bill)

It reflects a combination of biochemical changes in the body, the patient's personal history and memory, and the social situation. **Noncompliance:** Failure or refusal to conform to or follow rules, regulations, or the advice or wishes of another.

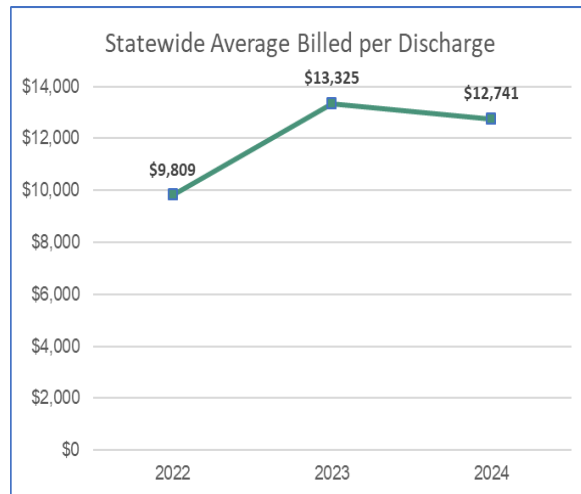


Chart IP 6-A Patient Discharges (Cases)

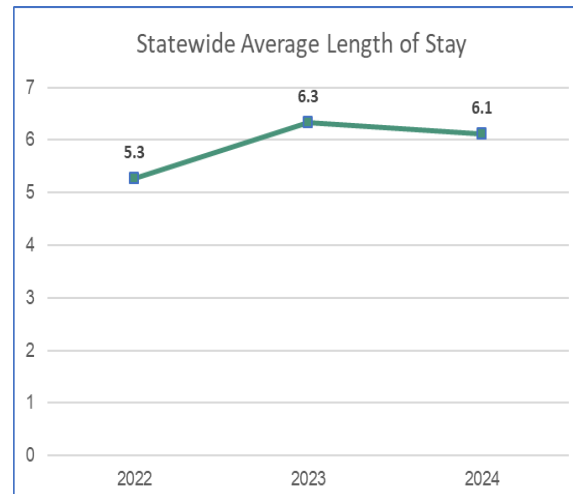


Chart IP 6-B Average Length of Stay (Avg LOS)

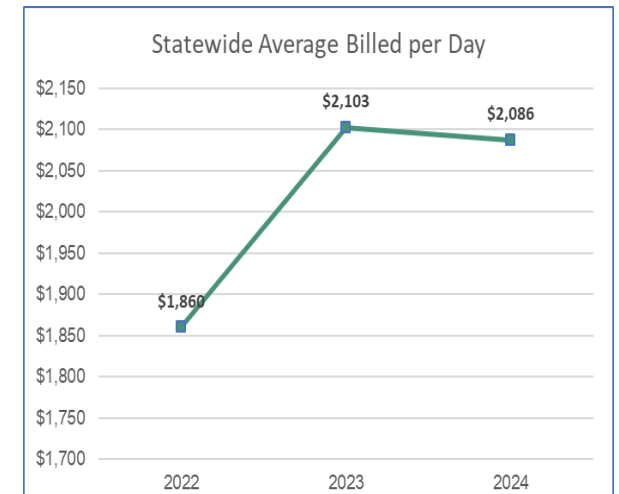


Chart IP 6-C Average Billed Charges (Avg Bill)

**Definitions:** **Mood disorder:** Any of a group of psychiatric disorders, including depression and bipolar disorder, characterized by a pervasive disturbance of mood that is not caused by an organic abnormality. **Attention deficit disorder:** A syndrome, usually diagnosed in childhood, characterized by a persistent pattern of impulsiveness, a short attention span, and often hyperactivity, and interfering especially with academic, occupational, and social performance. **Cannabis abuse:** The abuse of any of several mildly euphoriant, intoxicating hallucinogenic drugs, such as ganja, hashish, or marijuana prepared from various parts of this plant. **Tobacco:** Herb of South American origin, Nicotiana tabacum, which has large ovate to lanceolate leaves; leaves contain 2-8% nicotine and are source of smoking tobacco, chewing tobacco, and snuff. **Social maladjustment:** Maladjustment without manifest psychiatric disorder, such as that occasioned by an inability to cope with social situations. **Oppositional defiant disorder:** A recurring pattern of negative, hostile, disobedient, and defiant behavior in a child or adolescent, lasting for at least six months without serious violation of the basic rights of others.

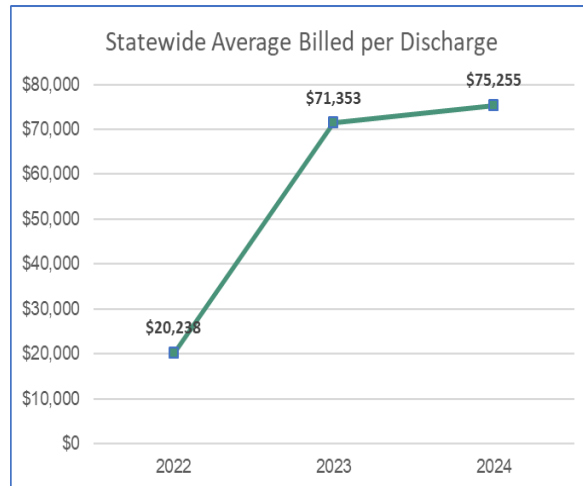


Chart IP 7-A Patient Discharges (Cases)

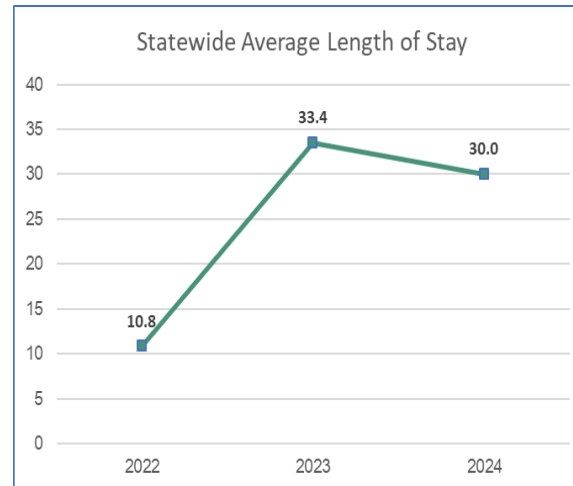


Chart IP 7-B Average Length of Stay (Avg LOS)

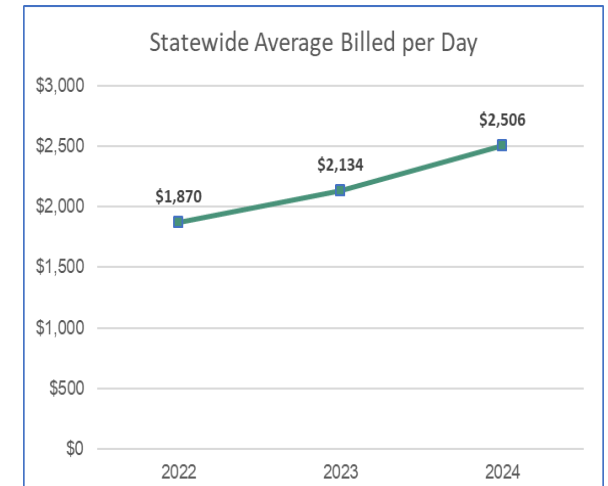


Chart IP 7-C Average Billed Charges (Avg Bill)

## 8. Psychoses (885) (MDC 19)

**MS-DRG(s): 885** - Psychoses.

**Definitions:** **Insomnia:** A sleep disorder that is characterized by difficulty falling and/or staying asleep. **Psychosis:** A symptom of mental illness rather than the name of a medical condition itself. 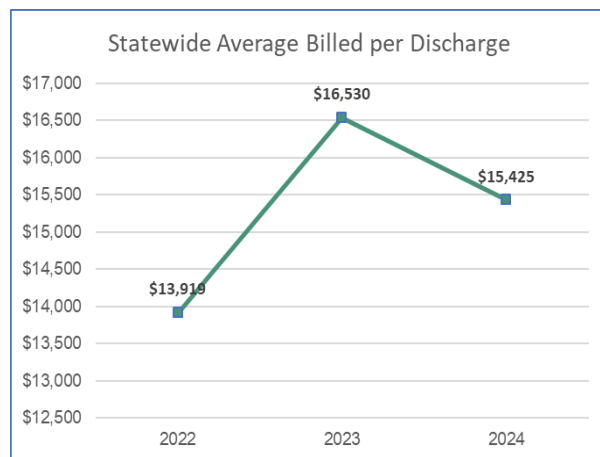


Chart IP 8-A Patient Discharges (Cases)

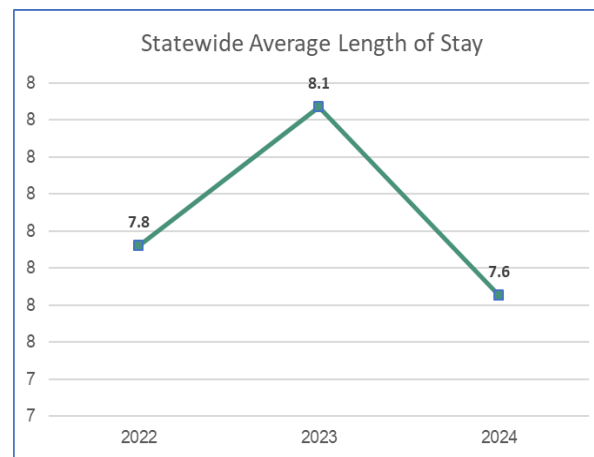


Chart IP 8-B Average Length of Stay (Avg LOS)

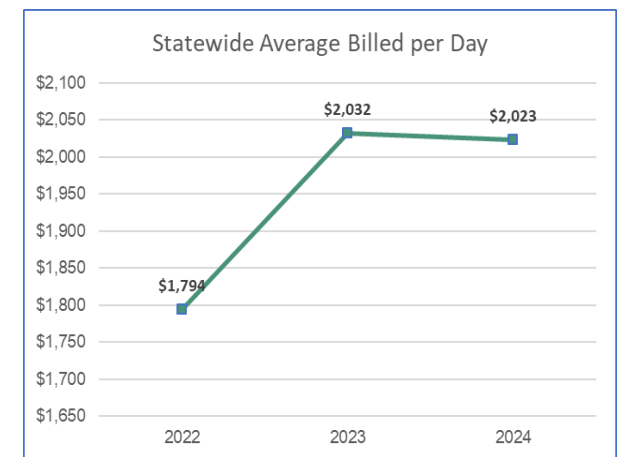


Chart IP 8-C Average Billed Charges (Avg Bill)

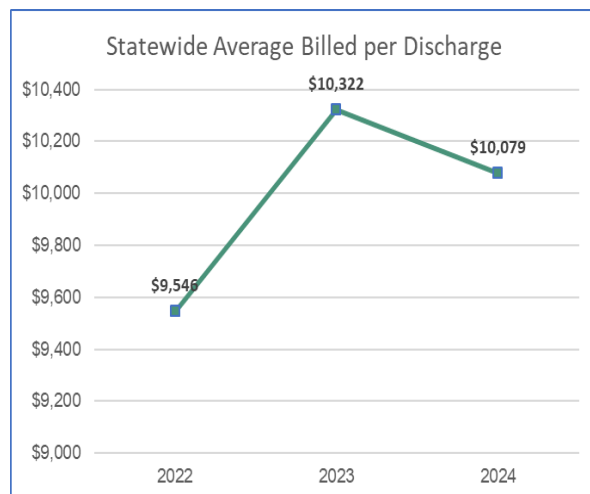


Chart IP 9-A Patient Discharges (Cases)

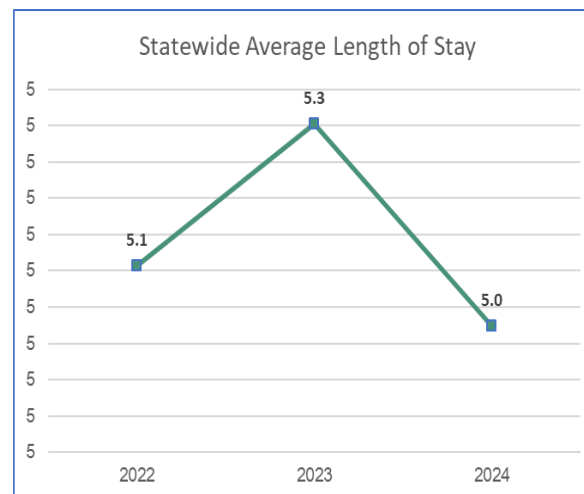


Chart IP 9-B Average Length of Stay (Avg LOS)

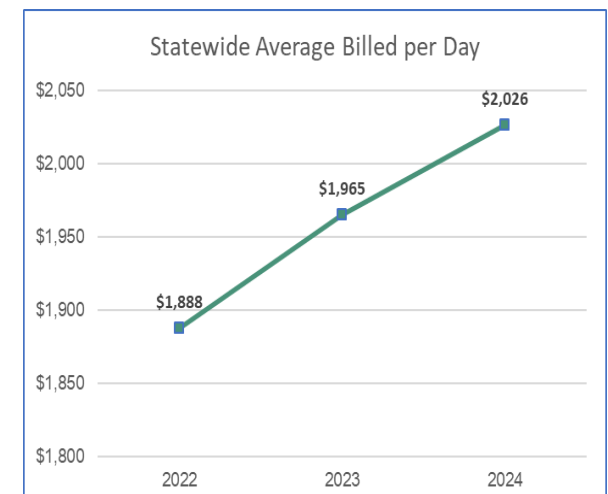


Chart IP 9-C Average Billed Charges (Avg Bill)

## 10. Rehabilitation With Complications (945) (MDC 23)

**MS-DRG(s): 945** - Rehabilitation With CC/MCC;

**Definitions:** **Atrial fibrillation:** An irregular and often very fast heart rate. The heart's two upper chambers (the atria) beat chaotically and irregularly - out of coordination with the two lower chambers (the ventricles) of the heart. **Chronic airway obstruction:** A type of pulmonary disorder, such as emphysema or chronic bronchitis, in which the upper or lower airway is chronically obstructed. **Hyposmolality:** The condition especially of a bodily fluid of having abnormally low osmolality. **Osmolality:** The concentration of a solution expressed as the total number of solute particles per kilogram. **Hyponatremia:** A deficiency of sodium in the blood. **Esophageal reflux:** Regurgitation of the contents of the stomach into the esophagus. **Reflux:** Backward flow of a substance. **Acute posthemorrhagic anemia:** A condition in which a person quickly loses a large volume of circulating hemoglobin. **Depressive disorder:** Any of a number of conditions characterized by one or more depressive episodes - major DD, depressed mood - dysthymic disorder and adjustment disorder with depressed mood, and those that do not fit the criteria of other conditions, aka, DD not otherwise specified. **Coronary atherosclerosis:** A hardening of the arteries, occurs when the normal lining of the arteries deteriorates, the walls of arteries thicken, and deposits of fat and plaque build up, causing narrowing (or even blockage) of the arteries.

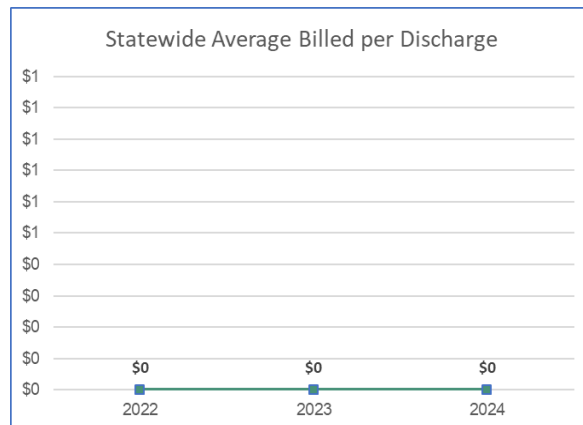


Chart IP 10-A Patient Discharges (Cases)

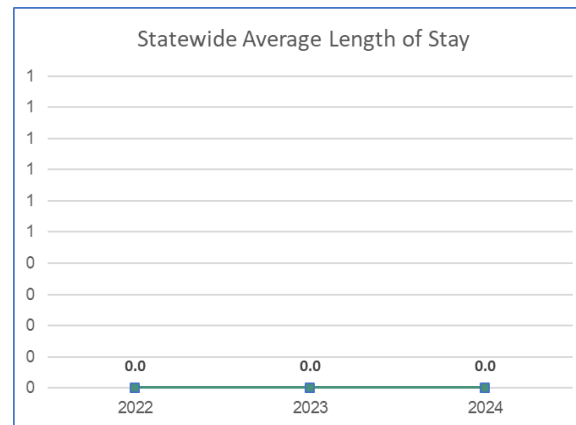


Chart IP 10-B Average Length of Stay (Avg LOS)

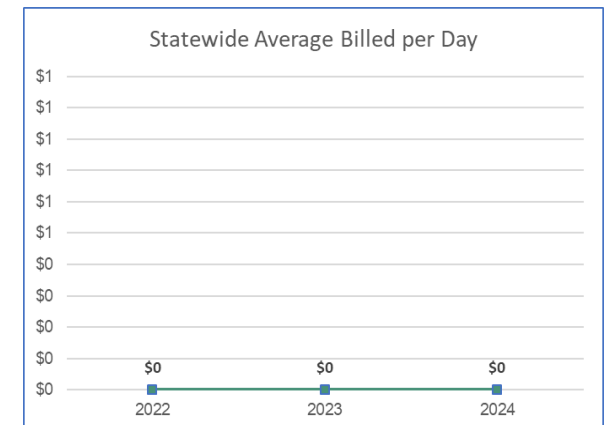


Chart IP 10-C Average Billed Charges (Avg Bill)

**MS-DRG(s): 946** - Rehabilitation Without CC/MCC;

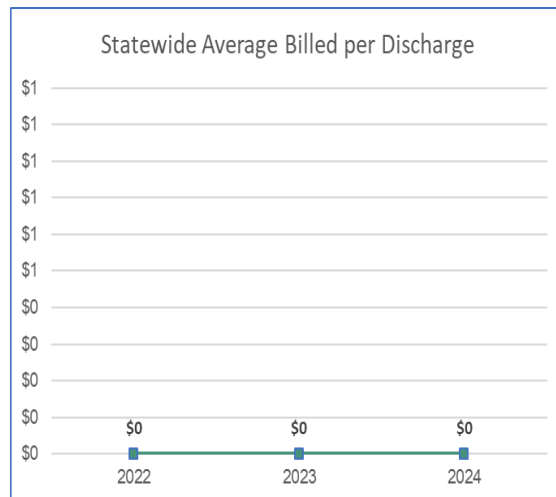


Chart IP 11-A Patient Discharges (Cases)

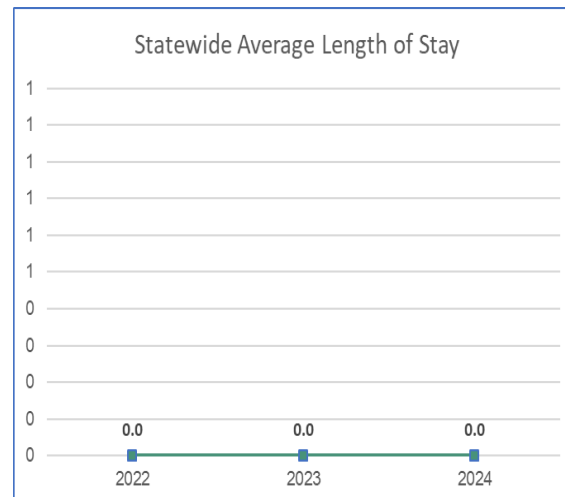


Chart IP 11-B Average Length of Stay (Avg LOS)

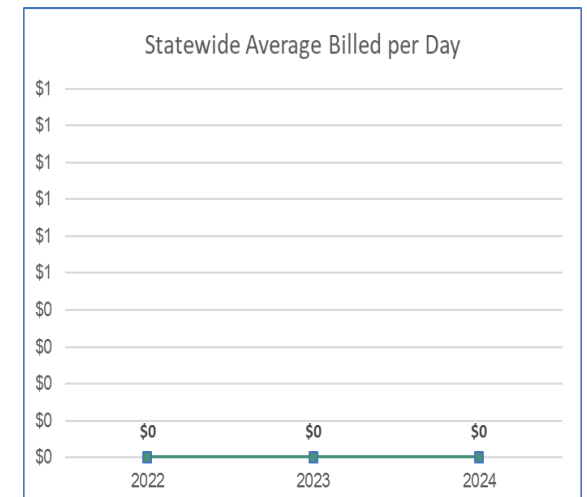


Chart IP 11-C Average Billed Charges (Avg Bill)
