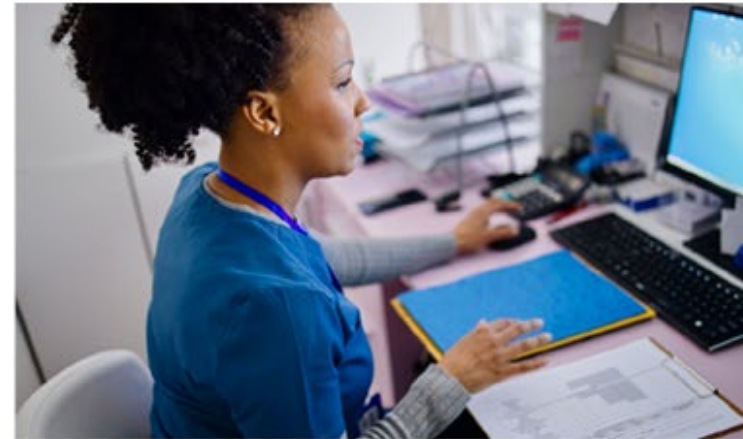

Foreword

Provider Preventable Readmissions is a joint publication of the Comagine Health and the Nevada Health Authority. This report presents six readmission measures for Nevada’s general acute care hospitals that discharged patients within the period. Readmission rates are often used as a quality benchmark for hospitals; they are defined as the percentage of patients who are discharged from an inpatient hospital stay and are then readmitted to a hospital again within 30 days. This report focuses on six common conditions and procedures where most patients will not be readmitted if they received high quality care during the first admission.

The data are available through the standard uniform billing form, which is used by hospitals to bill for hospital charges. The data include patients who were admitted for an inpatient stay. The data identify the percentage of patients who were readmitted to the hospital within 30 days of discharge for an unplanned hospital admission.

The data were compiled by Comagine Health using information from inpatient hospital billing records. This information was gathered and analyzed as part of a contractual agreement between the Department of Health and Human Services and Comagine Health under the authority granted in Section 439B of the Nevada Revised Statutes. Comagine Health reviews the data and requests corrections when errors are found. It is not possible to detect all errors. Comagine Health is not responsible for errors that cannot be found by a review.

Introduction

This Provider Preventable Readmissions compares 38 of Nevada's general acute care hospitals with respect to six common conditions or procedures that require hospitalization. The exception is for pneumonia readmissions; critical access hospitals (CAHs) are excluded from that section of the report and only 26 hospitals are included in the comparison.

Readmission Measure Methodology

The readmission measures were developed by Centers for Medicare & Medicaid Services (CMS) for the Medicare Hospital Readmission Reduction Program. The CMS measures report patients enrolled in Medicare; Comagine Health adapted these measures to report measures across all payers and include patients under the age of 65.

The CMS measures are also risk adjusted to account for the illness burden of the patient population. Due to data limitations, Comagine Health was not able to report risk-adjusted rates. This report includes observed (actual) rates of readmission.

Comagine Health has made one adjustment to the measure methodology. The readmission measures exclude original admissions for patients who have COVID-19 on admission. This is identified by either a primary diagnosis code of COVID-19, or a secondary diagnosis code that includes an indicator for present on admission. CAHs do not submit present on admission indicator on their UB04 claims. Any original admission with a diagnosis of COVID-19 were excluded for CAHs.

Additional Information

Personal Health Choices is intended as a source of information regarding the provider preventable readmissions for hospitals in Nevada and should not be construed as a definitive guide for selecting a hospital to receive medical care.

Report Navigation

This report includes Provider Preventable Readmission rates for acute care hospitals where the visit occurred in calendar year 2022 through 2024.

There are six readmission measures included in this report. Each readmission measure is introduced with a short narrative that describes the readmission measure.

After the narrative, a series of tables and charts are presented that include the number of index visits and the readmission rate. The first table presents statewide readmission rate along with gender and age breakdowns. The first table is followed by three charts to illustrate that same information. Following the charts will be three tables that contain the information by hospital for Clark, Carson City/Washoe County and rural counties.

It should be noted that when comparing hospitals, information based on small numbers of cases cannot provide a reliable statistical base upon which information can reflect a given hospital's experience. Rows that include fewer than five discharges are suppressed in this report, but caution should still be used when interpreting the data.

Comagine Health receives patient discharge records directly from all the hospitals included in this report.

Provider Preventable Readmissions – Discussion and Graphics

1. Acute Myocardial Infarction (AMI)

An acute myocardial infarction or AMI is more commonly known as a heart attack. This is a potentially deadly medical emergency where your heart muscle begins to die because it isn't getting enough blood flow. A blockage in the arteries that supply blood to your heart usually causes this.

Inpatient admissions where the primary diagnosis is AMI are included in this measure.

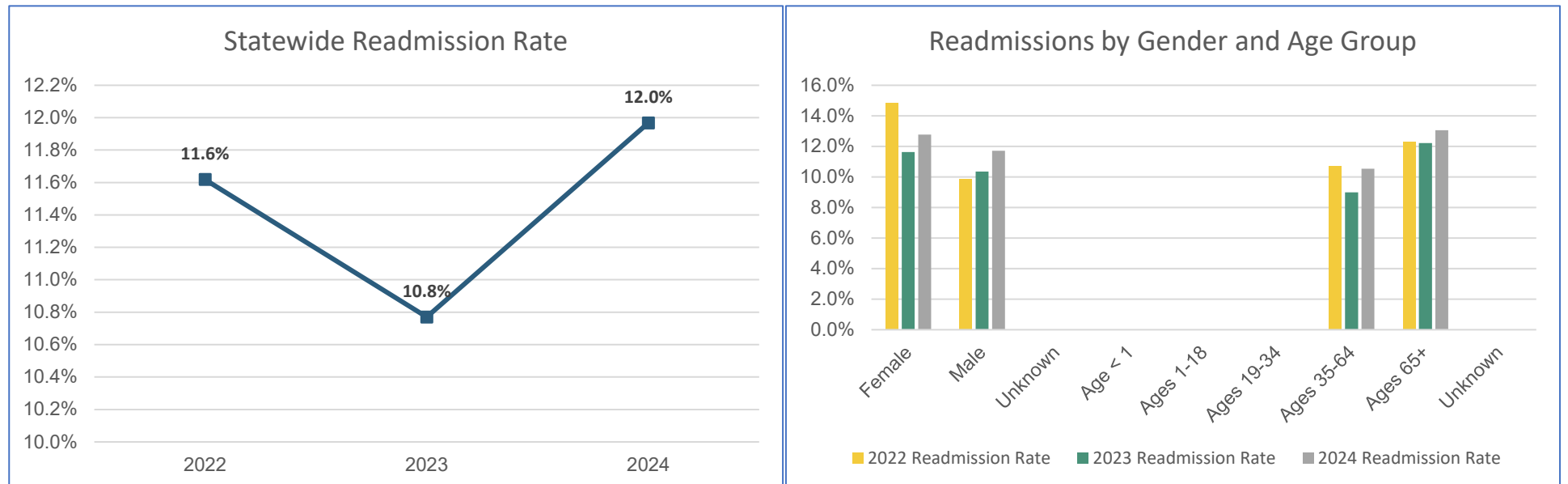

2. Heart Failure (HF)

Heart failure, also known as congestive heart failure, is a condition that develops when your heart doesn't pump enough blood for your body's needs. This can happen if your heart can't fill up with enough blood. It can also happen when your heart is too weak to pump properly.

Inpatient admissions where the primary diagnosis is heart failure and the patient did not have a left-ventricular assist device (LVAD) or heart transplant procedure during the hospital stay are included in this measure.

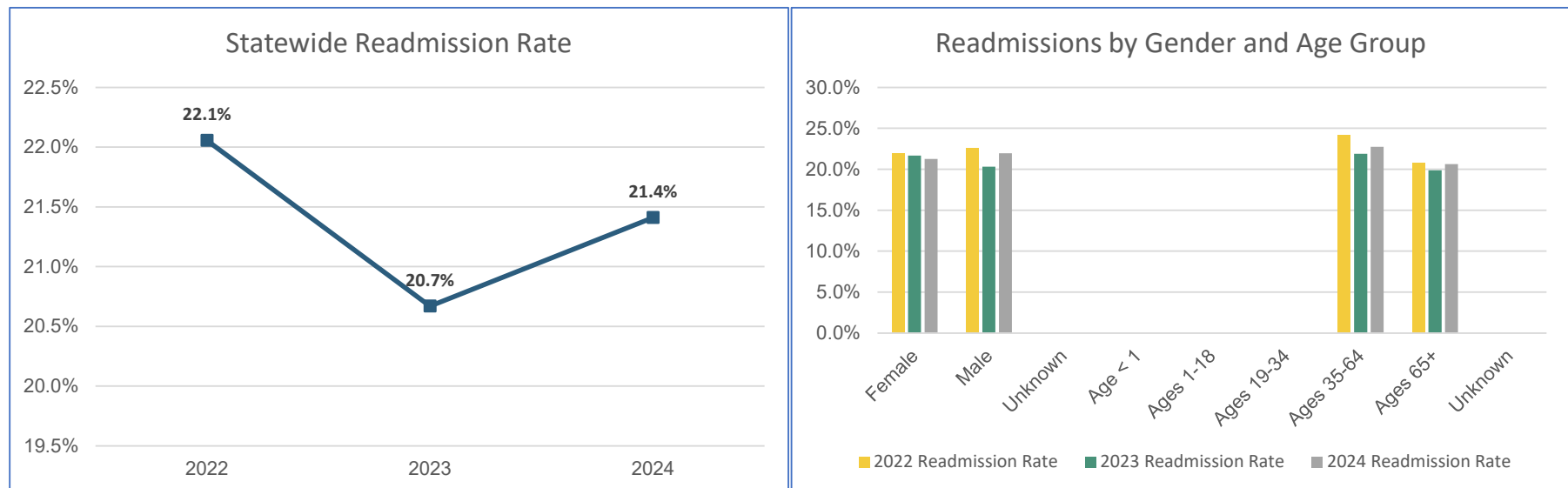

3. Chronic Obstructive Pulmonary Disorder (COPD)

Chronic obstructive pulmonary disease, or COPD, refers to a group of diseases that cause airflow blockage and breathing-related problems. It includes emphysema and chronic bronchitis.

Inpatient admissions where the primary diagnosis is COPD are included in this measure. Also included are inpatient admissions where the primary diagnosis is acute respiratory failure and a secondary diagnosis of COPD with exacerbation

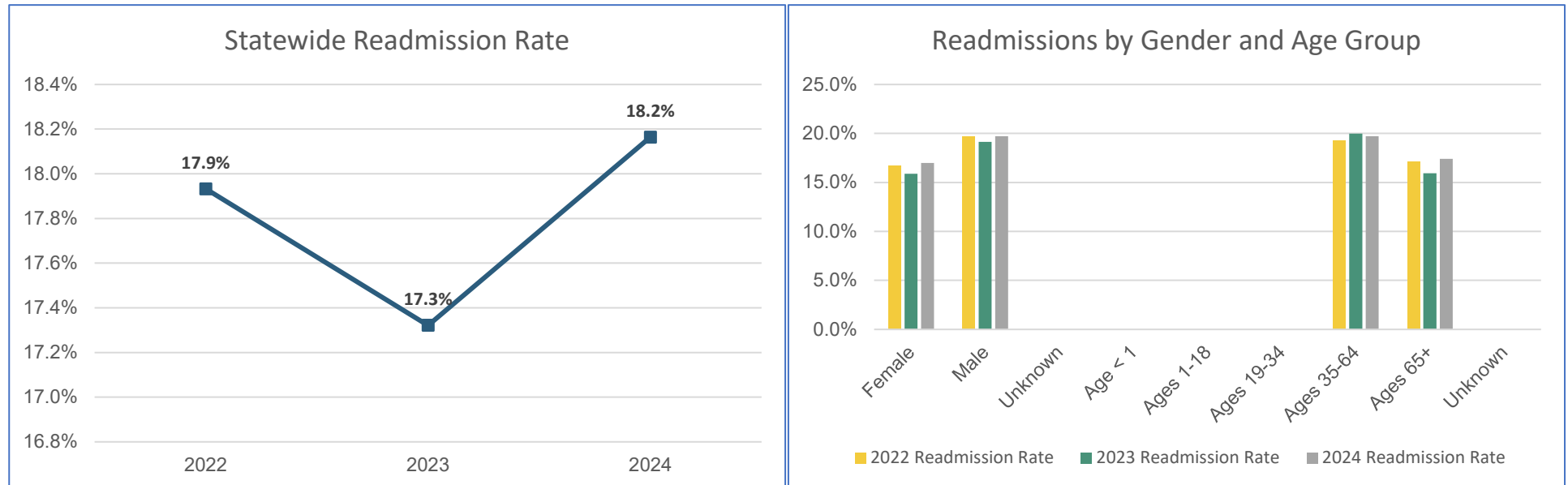

4. Pneumonia

Pneumonia is an infection that inflames your lungs' air sacs (alveoli). The air sacs may fill up with fluid or pus, causing symptoms such as a cough, fever, chills and trouble breathing.

Inpatient admissions where the primary diagnosis is pneumonia are included in this measure. Also included are admissions with a primary diagnosis of sepsis (that is not severe) with a secondary diagnosis of pneumonia that was present on admission and no other diagnosis of sepsis that is both severe and present on admission.

Critical Access Hospitals (CAHs) are not included in the pneumonia readmission measure. Pneumonia must be present when the patient is admitted to the hospital. Because CAHs do not submit present on admission indicators with their UB04 claims, there is no way to determine if the patient had pneumonia when they entered the hospital or if they acquired it during their stay.

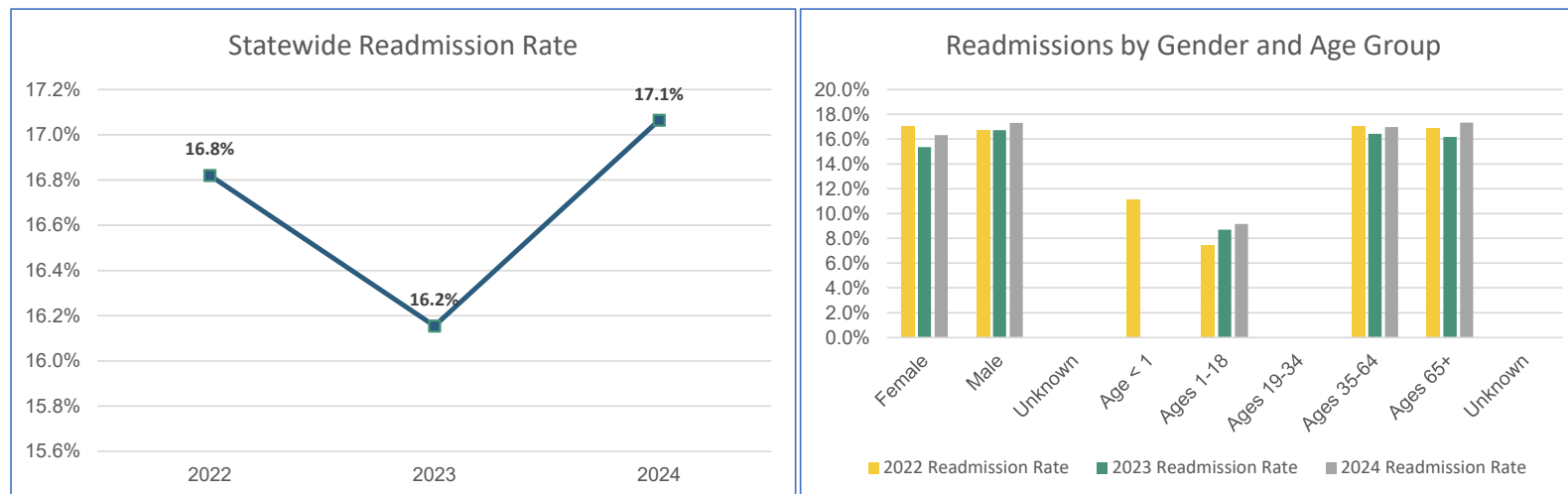

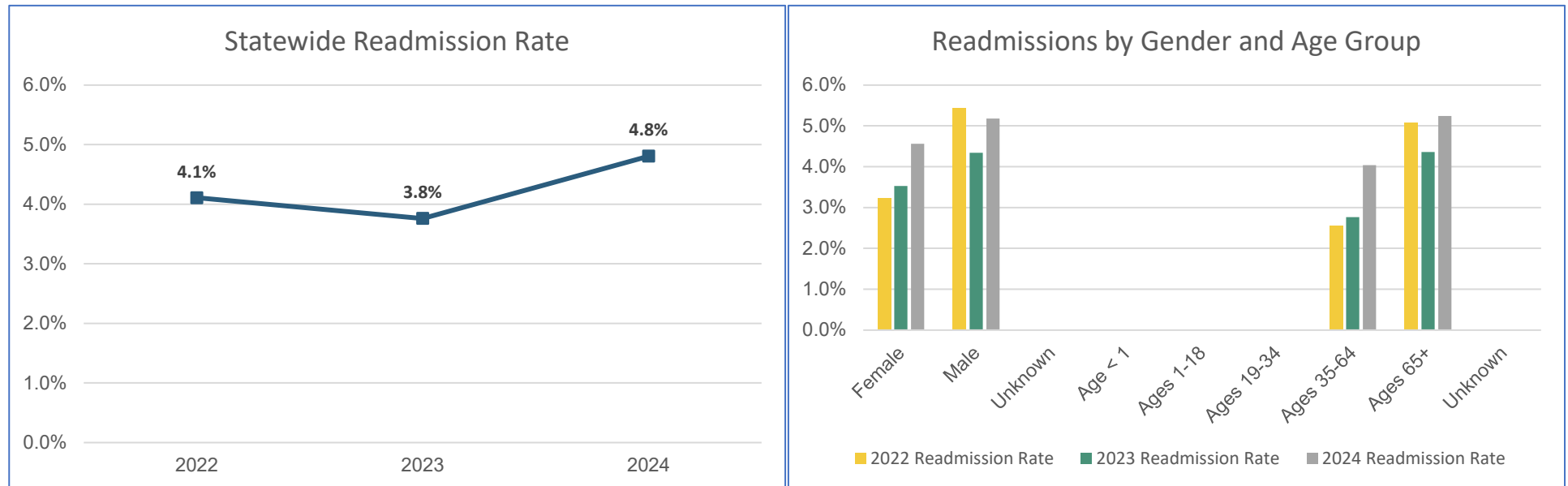

A coronary artery bypass graft involves taking a blood vessel from another part of the body (usually the chest, leg or arm) and attaching it to the coronary artery above and below the narrowed area or blockage.

Inpatient admissions where there is a CABG procedure, and there are no other major cardiac, vascular, or thoracic procedures performed during the same hospital stay.

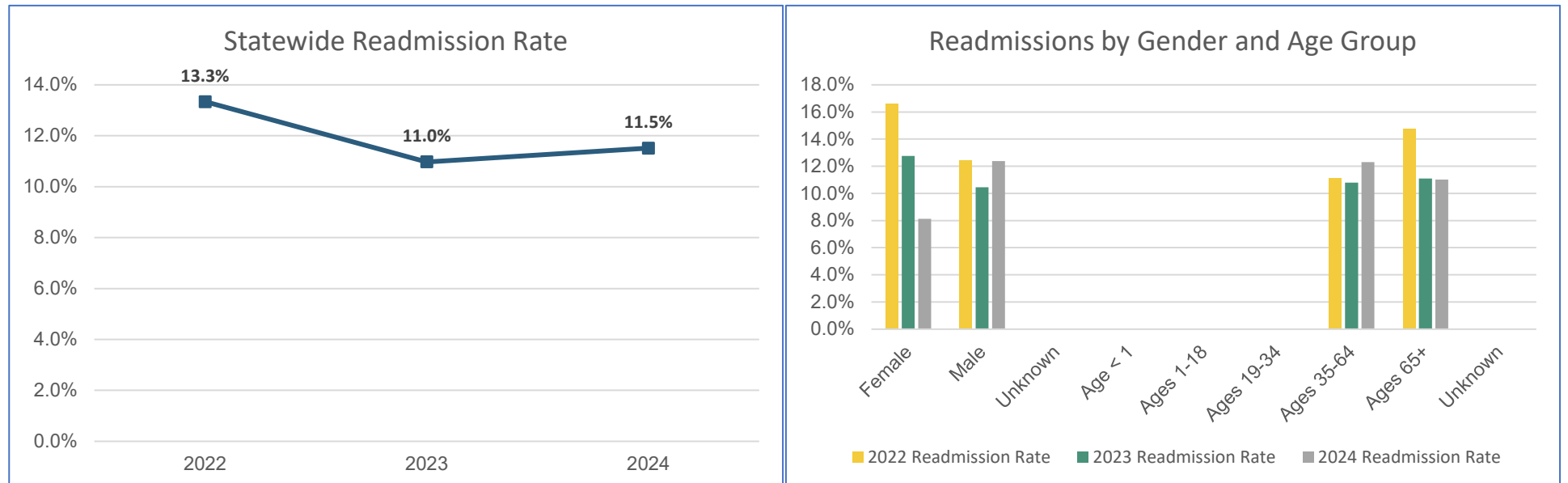
